The fourth repayment and distribution to unsecured creditors

This is to inform you that Wintek Corporation (“Wintek”) will carry out the fourth repayment and distribution to unsecured creditors in accordance with Wintek’s Reorganization Plan (“the Plan”).

1. The order and the decision on the confirmation of Wintek’s reorganization plan was approved and uploaded to Wintek’s official website:

2. In accordance with the Plan, Wintek has fulfilled the first, second and third repayment and distribution to all unsecured creditors, except for those creditors who have not yet provided remittance instruction documents to Wintek.
3. In accordance with the Plan, Wintek will carry out the fourth repayment and distribution of unsecured reorganization claims. The fourth repayment and distribution ratio is 8% of the claim amount. By adding the repayment ratio of the first to the fourth, the cumulated repayment and distribution is 40%.
4. For the fourth repayment and distribution, Wintek requires the creditors to cooperate as follows:

(1) **No information changes for creditors:** If there are no changes to the creditor’s name and the creditor’s remittance instruction account that was provided to Wintek for the distribution of the third or previous repayments, the creditor shall [reply to Wintek by email](#). Please note that the subject of the email should be “[Claim number], [creditor name] and for the fourth repayment, the remittance instruction account is the same with the third repayment”, and the Excel file containing all the information should be attached to the email so that Wintek can process the payment. Sample1 and sample2 are attached for your reference. If you

need to query the claim number, please check with Appendix 3 (list of claims) of the reorganization plan. Link below:

(2) **Only the person in charge of the company has changed:** If there are no changes to the creditor name and remittance bank account, but “the person in charge of the company” has changed, please fill out the attached “Remittance Instruction – For revision application (director)” and provide a hard copy of the company’s registration and existence certificates and supporting documents for name change of director, which should be mailed to Wintek to update the creditor’s information. Sample3 is attached for your reference.

(3) **The creditor’s name or Remittance Instruction bank account was changed:** If the creditor’s name (only in the case of creditor renaming) and/or the “Remittance Instruction bank account” was changed, please fill in the attached form “Remittance Instruction - For revision application (name and or account)” and provide a hard copy of the company’s registration and existence certificates and supporting documents for name change of director (if any), and the original Credibility Letter notarized by the local notary or the place of establishment.

Please mail the documents mentioned above to Wintek to update the remittance account. Sample4 is attached for your reference.

5. If the creditor replies by email to Wintek stating that the remittance account has no changes and attaches the excel file as requested, or if there are changes but the creditor has provided the requested documents by July 31, 2024, Wintek will expect remit the fourth repayment and distribution around the end of September.
6. The detailed rules for repayment and distribution shall be handled in accordance with the provisions of section 6, Chapter 5 of the Plan.
7. If the creditor has not furnished the remittance instruction documents or has not yet obtained the first to third repayment and distribution, please send the required documents as soon as possible.
